
Pediatrics

- 1. A total of 3,626 appointments were found without claims since 2021. Among these, 777 appointments were in 2023 and 953 appointments were in 2024.
- 2. Late claim creation is a significant issue: 1996 line items in outstanding AR were created 90+ days after DOS worth \$257K. Most of the claims may exceed the timely filing limits. Ex: Chart#5287 DOS 06/28/2023 created on 03/15/2024, Chart#5723 DOS 08/07/2023 created on 11/13/2023.
- A total claims worth of \$527K have been adjusted in 2023 under the 'WRITE OFF INSURANCE' code.
 However, some of the claims denied due to timely filing, bundled, coverage terminated, and MR required claims
 were also adjusted as 'WRITE OFF INSURANCE', without taking the step for the denial. Ex: Chart#7851 DOS
 03/23/2023, Chart#8374 DOS 07/14/2023, Chart#514 DOS 04/28/2023, Chart#8019 DOS 04/12/2023
- 4. ERA/EFT Activation has not been completed for Oscar, Ambetter, Humana, WellCare and PSHP insurances. Oscar and Ambetter are topmost payers in 2023 & 2024.
- 5. No follow-up and denial management. No denial or follow-up notes maintained. Ex: Chart#4427 DOS 07/31/2023, Chart#5688 DOS 08/28/2023
- 6. \$21K worth of claims were adjusted as timely filing in 2023 due to late charges
- 7. Claims worth \$12K (50-line items) from DOS 07/05/2023 are yet to be submitted. Ex: Chart#7077 DOS 09/16/2022, Chart#7502 DOS 01/17/2024.
- 8. 31 rejections are yet to be worked out. Ex: Chart# 4427 DOS 06/29/2022, Chart# 159 DOS 01/02/2023
- 9. The claims were not submitted on a daily basis.
- 10. Average inflation is 1.4 times of the Medicare allowed amount in 2023.
- 11. A standard fee schedule is followed for all payers which may lead to revenue loss.
- 12. No sign of instant patient statement submission. Statements were not sent regularly.






